### ZERO QUARANTINE FOR FOREIGNERS COMING TO COLOMBO DOCKYARD!

#### 1. What are the latest Covid – restrictions for Foreigners in Sri Lanka?

For fully Vaccinated foreigners there is no restrictions.

Accommodation	Any	First 7 days at Safe house, then any
Daily transport	Any/ Shuttle service by yard	Designated shuttle transport
Subsequent Covid testing	No	No
Restrictions	No	Free to the society after 7 days

#### 2. Who are considered as Fully Vaccinated?

- Persons who obtained recommended doses of covid-19 Vaccines and departed after two weeks from last dose
- Persons who have taken a single dose and had infected Covid-19 during the past six months
- Persons who had infected Covid-19 within past six months and had a single dose after infection

## RECEIVING VESSELS TO SHIPYARD

### **ZERO QUARANTINE FOR THE VESSELS ARRIVING COLOMBO DOCKYARD!**

1. **What are the latest Covid – restrictions for Vessels arriving and Ship-crew?**

For fully Vaccinated Ship-Crew there is no restrictions.

2. **The procedure to receive Vessels with Zero Quarantine to Colombo Dockyard.**

- a. Ship Master should submit following documents to shipyard prior arrival.
  1. Health Status report (HSR)
  2. Health Declaration Form (HDF)
  3. Maritime declaration of health
  4. Port of Call List
  5. Vaccination cards of all Crew members
- b. The vessel is permitted to enter port/ yard berth without any quarantine period with the clearance and acceptance from the Port Health Office for above documents.
- c. If all crew members are fully vaccinated by two weeks to arrival, vessel can be berthed/ docked for repairs.
- d. Else, PCR test would be performed on the none/ partially vaccinated Crew members at the Yard Berth/ Anchorage. With receipt of negative results for PCR testing, Shipyard team and Ship crew would be allowed to embark/ disembark to/ from vessel.
- e. Crew Changing during yard repairs is allowed for fully vaccinated on-signers.
- f. For non/ partial vaccinated crew signing-on, the respective person must undergo 7 days mandatory quarantine in approved Sri Lankan facility, followed by a PCR test, before signing onto the vessel.
- g. Afloat Repairs (at any Sri Lankan Port) would have further flexible working conditions depending on the job scope and location, evaluated case by case.
